**Minutes of Town Caucus
Tuesday, January 15, 2013**

Town Chairperson Mike Anderson called the Caucus to order at 6:30 p.m. at the Town Shed. A total of 19 town residents were in attendance.

Anderson requested nominations for Caucus Chairperson. Bobbi Knudson was nominated by Doug Rouzer, seconded by Mike Anderson. Motion Carried.

Arnie Peer made a motion that voting be done by written ballot. Seconded by Sue Rouzer. All present voting "aye". Motion Carried. Dick Naessen and David Knudson were appointed to serve as ballot counters.

Knudson called for nominations for the position of Town Chairman.

Ballots were cast for Arnold Peer, Doug Rouzer and Mike Anderson.
Arnie Peer declined.
Mike Anderson and Doug Rouzer will be on the ballot for Chairman.

Knudson called for nominations for the position of Town Supervisor (2)

Ballots were cast for Doug Rouzer, Joe Zaspel, Paul Danniger, Dick Naessen, Merlin Richter and Arnie Peer. Paul Danniger, Dick Naessen and Arnie Peer declined. Merlin Richter was not present and later declined. Doug Rouzer and Joe Zaspel will be on the ballot for Supervisor.

Knudson called for nominations for the position of Town Clerk.

Ballots were cast for Carol Wallin and Deanne Moravitz.
Carol Wallin (not present) later declined.
Deanne Moravitz will be on the ballot for Clerk.

Knudson called for nominations for the position of Town Treasurer.

Ballots were cast for Susan Rouzer, Alice Verby, Kitty Anderson, Bobbi Knudson and Tom O'Hern. Alice Verby was not present. Kitty Anderson, Bobbi Knudson and Tom O'Hern declined. Susan Rouzer and Alice Verby will be on the ballot for Treasurer.

Motion Zaspel/Rouzer to adjourn the Caucus at 6:55 p.m. Motion Carried.

All of the nominees qualified for ballot placement by completing the required Declaration of Candidacy and Campaign Registration Statement forms. A drawing was held to determine ballot placement.
