## Clean Water Clean Boats Program Dick Hollar

For your amazement, the following is some state-wide statistics on the Clean Boats Clean Waters Program:

**65,831 boats were inspected**  
**142,104 people were talked to regarding CBCW**  
**38,309+ hours were spent conducting inspections**  
    70% by paid inspectors  
    30% by volunteers  
**91% of boaters were aware of the laws**  
**95% said they inspected their boat and equipment for plants and removed any found**  
**31% said the best way for them to get AIS info was through the person at the boat landing**

## REALITY CHECK - THE TIME IS NOW

If a tree falls in the forest and no one hears the crash, is there still a sound? Leaving aside the philosophic issues, that question is a metaphor for public service. Elected officials and unseen volunteers at the local levels, even our own little lake district, do a lot of work to promote the common good. Still, most of the public just doesn't seem to be paying attention. Is there still a sound? Do people really care about the issues and the challenges facing us? Do they care about the plans put together by public agencies, commissions and councils? More importantly, do the people feel it's necessary to do something themselves to make the world a better place?

What can we do to help the public hear the sound and do what needs to be done? Here at Pipe Lakes, we could paraphrase John F. Kennedy's immortal words of 50 years ago, "Ask not what your Lake District can do for you, ask what you can do for your lake."

The Pipe Lake Commissioners have put together some ambitious and far-reaching plans to assure that the Pipe Lakes continue to be among the cleanest and healthiest in the state of Wisconsin. That means Pipe Lakes will continue to be one of the best values when it comes to owning lake property here. We can point with satisfaction to our comprehensive system of measurements, data recording and analysis of lake quality; large outer watershed projects like the proposed retention basin on the northeast corner of North Pipe Lake; social events like the boat parade and picnic where we can celebrate our successes; and the shoreland protection projects undertaken by individual homeowners.

According to environmental professionals, this last category, **homeowner initiatives on their own property, will have the greatest impact on the quality of our lakes in the future.** Why is it so difficult, then, to get homeowners involved in doing improvements that improve the value of their property AND help preserve and protect the quality of our lakes for everyone?

Your commissioners are constantly discussing, debating and re-thinking communication strategies that will spread the word about our work, but especially the opportunity for homeowners to do their own shoreland protection projects, **using the matching funds now available.** We want to create a groundswell of public interest in the program. We want your ideas on how we can better communicate the value of shoreland protection programs to the homeowner and get more people involved.

Maybe we need a reality check. The District can offer these matching funds now **only** because it secured a \$200,000 grant from the State of Wisconsin last year. That grant is likely, due to economic realities, to be the last piece of support from the state of Wisconsin for environmental protection for decades. Almost every state is in the same boat—they're all in financial trouble. Lake protection efforts will likely slip to the bottom of the priority lists.

Whatever your politics, whether you're delighted with or terrified by the drastic cutting of public expenditures on all levels, we must accept the **reality that this is probably our last chance to make this kind of investment in our lakes!** If we don't do the right thing now, we'll end up like so many other lakes throughout the state, putting our fingers in the dike, so to speak, long after the waters have come over the top.

Your lake district is committed to using these grant funds in a way that gets the biggest bang for the buck for all of us. The most important piece is what individual homeowners do with their own property. It's up to you. The time is now. Please sign up for the free property reviews offered through our grant to learn what you can do to enhance your property.

## DNR ENDORSES CURRENT CULVERT LEVEL

The DNR notified the District that the current culvert level is correct on the south end of Pipe Lake. The culvert has been controversial since the resetting of the culvert in 1996 that lowered the overall level of the lake. The DNR reviewed its records and current positioning measurements and has determined that no further action is required because the culvert is set correctly.
