<u>Road Maintenance</u> – Rouzer stated that the culverts are in and ready for installation. Digger's hotline has been out and marked for culverts on east end of 235th St. Supervisor Anderson will follow up with Digger's Hotline to mark for the remaining culverts; (2) on 210th, just east of 10th St. and (1) by Paul Pett's driveway. Progress has been made on the beaver dam on 240th. Intersections of 45th and 235th, and Pipe Lake Road and 220th have been cleared. All gravel has been hauled and spread. Pipe Lake Road has been patched. Work will be done on north end of Pipe Lake and also on 45th St.

Rouzer requested that the green shoulders on the gravel roads be graded.

Verbal rate and term quotes for possible borrowing were provided. Best rate given was 2% for 2 years. Final determination will be made at a future meeting regarding the necessity to borrow funds to complete road repairs and major maintenance projects.
