<u>Supervisor Reports</u> – Chairman Anderson is preparing to apply for LRIP/TRI funds and received a bid from Monarch to repair the roadway from Pipe Lake Bridge, east to CTH G and 20th south to CTH G. The cost estimate of \$62,595.97 was provided by Monarch Paving. This information will be used to apply for LRIP funds reimbursement.

Zaspel asked that trucking company be contacted now to schedule gravel hauling that we intend to complete next season. Culvert on 220th was plugged with beaver clippings.
